Thank you for using our products and services ("Services"). The Services are provided by Verdant Academics Ltd, located at Schoolhouse Yard, Bloomfield Road, London, England, SE18 7JD.

By using our Services, you are agreeing to these terms. Scope of Services

Adaptation

Involves the conversion of existing educational resources (e.g., documents and presentations) into LMS/VLE compatible formats with minimal additions in terms of bespoke content. This service does include bespoke design elements in line with the client's brand guidelines.

Adaptation Plus

As above but includes:

- Enhancement of client's existing resources with original visual elements such as graphic organisers, interactive features for guided discovery, and Problem-Based Learning tools.
- Additional development costs and timelines apply to incorporate features, such as but not limited to, 3D explorable elements, storylines, and scenarios.

Complete Bespoke Service

Tailored content development starting from assessment outcomes to create a comprehensive package including specifications, content, interactivity, gamification, visuals, 3D elements, and in-built assessment materials.

Additional Costs and Timelines

Any added features beyond the basic adaptation will incur extra development costs and extended timelines. Clients will be provided with transparent and detailed cost breakdowns.

Online Platform Provision

Offering an online platform for the developed content is an optional service incurring an additional cost. The client is responsible for specifying their platform requirements.

Transparent Communication

Verdant Academics Ltd is committed to transparently communicating any additional costs associated with project expansions or changes. Projects evolving organically to include more customised content will be subject to

supplementary charges, with all adjustments discussed openly with the client.

Client Responsibilities

The client is responsible for providing necessary materials for adaptation or specifying requirements for the bespoke service.

Any delays in client-provided materials or approvals may affect project timelines and may result in additional costs.

Payment Terms

For non-project Services/Products, payment is expected 30 days following invoicing.

For projects, milestones will be clearly outlined in the project proposal in the form of a Service Agreement and Statement of Work document (SoW). Milestone reports are usually accompanied by an invoice for payment against the deliverables associated with the milestone. Verdant Academics Ltd reserves the right to withhold deliverables until the corresponding payments are received.

For sizeable projects and/or projects that involve a significant amount of bespoke content creation, an initial deposit of up to 50% may be required.

Intellectual Property

Upon full payment, there are a number of possible outcomes regarding Intellectual Property depending on the Service/Product the client has opted for. In cases where the client gains ownership over the Intellectual Property of the developed content, Verdant Academics Ltd retains the right to reuse non-client-specific elements for future projects unless an alternative agreement is made in writing. Please see below for further details.

Confidentiality

Manual Sharing

This mode refers to the act of us transferring the file of the Service/Product to you in a format of your choice (examples of this include but are not limited to, AICC, SCORM 1.2, SCORM 2004, xAPI (Tin Can) and HTML5) via an online file-sharing service provided by a 3rd Party. Via Online Portal

This refers to the mode of access whereby we host and maintain your Service(s)/Product(s) on the cloud and you access them via an online portal which is seamlessly integrated to your own LMS (Learning Management Software) or VLE (Virtual Learning Platform), assuming this a service you already have in place. Verdant Academic Ltd manages and maintains their cloud space, supported by their trusted 3rd-party contractors. As such, 3rd-party terms and conditions as well as policies will apply. Client portals are subject to usage fees, billed annually.

Cloud hosting allows us to automatically update your Service/Product remotely. This will be done by us as per your requirements and may be subject to charge. In addition, with this service we offer the simple update service (updates that do not require significant new content creation), free of charge.

Via SCORM Wrapper

Transfer of exported content with a SCORM wrapper feature is similar to the manual transfer method in that Verdant Academic Ltd supplies the client with a zip file to be uploaded to the client LMS/VLE. The additional feature of this method of access is that it allows us to maintain a link with the content. As such, we offer the simple update service

(updates that do not require significant new content creation), free of charge. Wrapped files are subject to expiry dates and require renewal purchasing.

Per-User Access

Verdant Academics Ltd offers per user access to online Services/Products through collaboration with a trusted 3rd-party subcontractor. In this collaboration Verdant Academics Ltd operates as a Reseller Partner and as such provide extensive but not absolute support and technical guidance in configuring the service/product on your behalf. Where necessary, you may be referred to the sub-contractor's technical support and/or customer services.

Multiple User Access

This mode involves the sale of access licences in the form of "seats" to Service(s)/Product(s) hosted on the Verdant Academics Ltd portal.
